VI. Field Safety Report – Ty

- Propeller Arc / EDF Ingestion Safety Hazard
 - All members are reminded to set “THROTTLE CUT” modes on their transmitters.
 - Keep body parts, loose articles of clothing, tools and any foreign objects away from the propeller arcs and EDF intake areas at all times.
- 11 February: Fxt #2 replaced.
- 2 March: No reported injury / events.
 - Fxts, AED and 1st aid kits functional. Fuses replaced in charging station.
- 1 April: No reported injury / events.
 - Fxts, AED and 1st aid kits functional. Charging station operational.
- CLARIFICATION: “*Field Rules PROBATIONARY PERIOD*” – Dan / Ty
 - Currently, a 90-day time period is specified for a new member to allow an individual to demonstrate proper safety awareness and skills consistent with the continued presence of the club, the best interest of the neighboring residents and county land owners.
 - Proposed was granting full time membership to probationary members who clearly demonstrated such safety awareness and skills ahead of the 90-day period upon review by the club board of directors.
